Governmental Affairs

The FTC has proposed a rule to ban almost all non-compete clauses across the country. This move raises significant concerns about the FTC's statutory authority and its approach to this sweeping ban. The FTC is set up to be an administrative body that evaluates the facts on a case-by- case basis to determine whether business conduct constitutes an unfair method of competition. It is not empowered to broadly write its own rules to regulate the economy. Bottom line: Only Congress can write laws that regulate competition in the economy or choose to regulate non-competes in such as sweeping fashion.

Non-Competes:

The FTC's massive over reach on non-competes is unparalleled

- Non-competes are a form of restrictive covenant agreement that when appropriately used serve a legitimate and lawful purpose.

- For this reason, a blanket federal ban makes little sense and is impossible to justify. In fact, the proposal was labeled by former Secretary of Labor Eugene Scalia as perhaps "the most audacious federal rule ever proposed".

- The FTC's proposed approach, if finalized would rewrite by its own estimate 30 million contracts and pre-empt laws regulating them in nearly every state.

- All but three states allow them, while also placing limitations on their duration, geographic scope, and in some cases banning their use with lower-wage workers.

The FTC's blanket ban ignores legitimate reasons for non-competes

- Employers use agreements that can be mislabeled as non-compete agreements for a wide range of legitimate purposes that are both pro- employee and pro-employer Examples include:
 - To protect intellectual property and trade secrets.
 - For a reasonable time, to prevent non-solicitation of their customers.

- To reward senior executives, particularly in start-ups and small businesses, reward these key employees with significant equity in the business.

- To require, as part of complex compensation and talent management plans, things like stock grants, bonuses, training costs, etc. to be repaid if an employee were to depart for a competitor shortly after getting these rewards.

- As part of severance payouts.
- The FTC's proposed sweeping ban provides no clear safe harbors for such common practices.

The FTC's blanket ban may harm more workers than it helps

- A blanket ban would force companies to rethink their compensation and talent acquisition strategies in ways that might reduce what companies are willing to pay for top talent. A blanket ban would chill the incentives to pay bonuses, award equity, pay severances, and invest in the skills of their employees.

- Employees that choose to stay with their employer can also be harmed. When fellow employees leave for a competitor and take with them sensitive business information, client lists, and other proprietary information, those still working for the employer have been unfairly harmed.

- The FTC claims its proposed ban will lead to higher wages. Yet, they provide no concrete economic analysis to back their numbers.

On February 1, 2023, the Sauk Valley Community Leadership Program cohort began class at the YWCA of the Sauk Valley with a presentation by Executive Director Rebecca Munoz-Ripley. Munoz-Ripley's eye-opening, interactive discussion focused on diversity, equity, and inclusion. After a short break, a panel of experts helped us explore multiple forms of oppression within society and what we can do to become allies. Lunch from Sophie's Cafe was fantastic.

We began class on February 15th with an insightful presentation by Tom Wadsworth about "10 proven principles of media relations that can help anyone survive and thrive when the news media come calling." We rounded out the morning with a continuation of what we began in October with Danny Langloss, retired Dixon Police Chief and

current Dixon City Manager. Langloss helped the cohort shift their thinking from having a "difficult" conversation to having a "caring" conversation, and he walked us through specific scenarios. Langloss' engaging, interactive presentation was followed by an extraordinary lunch from Basil Tree Ristorante of Dixon.
