Illinois enacts overdue first step in ethics reform

Illinois Policy Institute experts say lawmakers must pursue additional anti-corruption measures

SPRINGFIELD, III. (Oct. 12, 2021) — Gov. J.B. Pritzker officially certified Senate Bill 539 Friday. The omnibus ethics package, which will be effective Jan. 1, 2022, takes a step toward reforming Illinois' extensive culture of corruption, but more remains to be done.

In addition to changing certain laws governing political fundraising and rules affecting lobbyists, the bill amends the Illinois Governmental Ethics Act to broaden the information required in the financial disclosure statements filed by certain public officials and bars lawmakers, executive constitutional officers and elected officials of units of local governments from being employed as lobbyists while in office under certain circumstances. It also allows the legislative inspector general to open investigations into complaints of wrongdoing against lawmakers and mandates legislators must adhere to a short waiting period before becoming lobbyists.

Pritzker issued an amendatory veto to make a minor technical fix to the bill in August, which the General Assembly approved Sept. 9.

These reforms fall short of what is needed, Institute experts say. Illinois lawmakers must return to the issue and do more next year if they are serious about combatting the pervasive culture of corruption in the state.

Analysis of the ethics package finds:

- Bill language allows for a lawmaker to retire from the General Assembly and, after waiting a six-month period, become a lobbyist during the remainder of the term for which they were elected to office.
- The six-month period only applies to lawmakers who attempt to lobby the General Assembly they served in, so if a lawmaker resigns the day prior to a new General Assembly, that lawmaker could skip the "cooling off" period completely.
- The legislative inspector general now has the power to open investigations of complaints without the
 approval of lawmakers on the Legislative Ethics Commission, so long as it's within one year of the
 incident. The inspector general's jurisdiction has been limited to investigating violations of the
 Governmental Ethics Act and violations of laws and rules related to, or other misconduct related to,
 public duties or use of state office, employment or resources.
- Lawmakers and certain other public officials are required to provide broadened financial disclosure information. Most assets and debts worth more than \$10,000 and income sources over \$7,500 must be disclosed.
- A new ban prevents lawmakers from lobbying for an entity that's also registered to lobby the particular unit of government they serve.

October 6th's SVLP class began at the Dixon Public Safety Building with a recap of the DISC assessment. Students then explored the Northwest Territory Historic Center (Dixon's own Smithsonian-affiliated museum). Geoff Vanderlin, retired Executive Director of the Lee County Council on Aging, then treated us to the lesser-known Dixon-area history.



After the tour, Steve Nunez, Pennsylvania Highlands Community College President, began what will be a two-part series on Strategic Planning and Time Management. After looking at criteria for strong mission statements, Nunez tasked students with finding the mission statements of their organizations, asking students to write a mission statement for the SVLP. Class concluded with fantastic boxed lunches by Curate in Dixon.

At Mama Cimino's banquet room, class began with an insightful Q & A with Dr. Bill Bird, CGH, who recommended that emerging leaders ask good questions and remain open listeners in conversation. Dr. Joyce Johnson, KSB, also reminded students to lead with humility and compassion, focusing on what we can control, which is our response to others, not their response to us.

Our next panel included the following medical professionals: Dr. Linda Hellmich, KSB; Dr. Kelly S. Flanagan, Florissa; Valerie Kern-Lyons, SVCC; and Natalie Moeller, Moeller, Myers & Associates, PC. Students learned of challenges, such as: a scarcity of resources and the high need within the community. Panel members also gave





these emerging leaders some important advice: accept criticism; don't take ourselves too seriously; stop apologizing; and own any mistakes and grow from them. Mama Cimino's provided the class with a delicious buffet lunch.

WORKFORCE DEVELOPMENT

The SVACC Education Committee is again working with local high schools to provide a Certificate of Employability 6 Session Workshop. This initiative is an example of bridging the gap between students/education and employers/businesses. Students who participate in the workshop are given the opportunity to gain information about the local











businesses in the area and the various career pathways available right here in the Sauk Valley. They also learn about the importance of essential skills in the workplace. The six session topics include:

- How to get the Job
- Work ethic
- Professionalism

- Communication
- Teamwork/Collaboration
- Problem Solving/Critical thinking/Creativity

The classes have been very interactive as students are interested in learning about local businesses and the types of jobs available to them locally. Upon completion of this workshop, participating students will receive a certificate of completion that can be used when they are applying for employment.

Employers who participate in the project gain visibility for their business and are given the opportunity to share about the jobs available in their place of business SVACC. The commitment from a business/ organization is just one session in the six-week series. As the education committee developed this project, we felt it was important to give as many member businesses as possible the opportunity to engage with local students.

Kris Noble attends each session with the employer and facilitates a discussion about the identified essential skill, provides an activity for the students, and introduces the guest business speaker. The class has been really well received by the students and teachers. We anticipate working with 3-4 high schools in Spring 2022 and invite you to join us as part of this initiative.
