Employment Law Council Update on HB 2862, Day Labor Services

Earlier this week with the signing of HB 2862 into law, the Illinois Chamber Employment Law Council released the following to its members:

If you use Day Labor Services to meet your workforce needs, you will want to be aware of the new law that creates new responsibilities and obligations as a third-party client of those services.

In response to the Governor's signing of HB 2862 into law as PA 103-437, the Illinois Department of Labor (IDOL) has issued emergency rules effective August 4, 2023. The new law and regulation are effective August 4, 2023.

The emergency rule makes extensive changes that affect the responsibilities and obligations of employers who use day and temporary labor services. In general, the emergency rule:

- · clarifies day and temporary labor services agencies' responsibilities to pay certain laborers wages and benefits equal to those of direct-hire employees of the third-party client;
- · increases fees and fines per the law for third-party clients;
- · authorizes laborers to refuse assignment to the site of a labor dispute;
- outlines for procedures for an interested party to pursue a whistleblower action against third-party clients;
- · clarifies parties' responsibilities when IDOL, the Office of the Attorney General, or another party are pursing related actions at the same time; and
- · clarifies the obligation of day and temporary labor service agencies and third-party clients to inform and train laborers regarding work site hazards.

Business Employment Skills Team, Inc. (BEST, Inc.) is a federally-funded not-for-profit agency that provides training assistance to eligible individuals and businesses in the eight county area of: Jo Daviess, Carroll, Whiteside, Lee, Ogle, Bureau, LaSalle and Putnam Counties. Adults, dislocated workers, and youth can receive assistance with: getting their GED/HS Equivalency, career exploration and guidance, classroom training, and job placement assistance. Business can benefit from On-the-Job Training reimbursement for hiring eligible individuals, and incumbent worker grant assistance for upskilling their current workforce.

BEST, Inc. has partnered with the Sauk Valley Area Chamber of Commerce (SVACC) on the innovative Drive-thru Job Fairs. This began during the height of the COVID pandemic and was a safe way to help area businesses fill open positions and minimize the exposure to job seekers from the COVID virus. Businesses who had positions to fill were contacted and sent their fliers to the chamber who assembled the packets. During the actual "Drive-thru Job Fairs" BEST and Chamber Staff were outside in a designated area and job seekers just drove up and received a packet of job leads from area businesses. Staff were on hand to answer questions and direct job seekers to local resources too. Left over packets were distributed to local community

agencies and were also on hand at BEST, Inc. as part of out "Job Leads to Go" program. All fliers used in the "Drive-thru Job Fair" were also scanned and BEST and Chamber staff were able to email them to those who could not attend the fair. Kris and her staff worked tirelessly assembling the packets and being a drop off point for businesses. The SVCC has also been instrumental and help us spread the word about services, hiring events and special events offered by BEST, Inc. to area businesses.
