City Manager Orvin stated removal of excessive and heavy debris has become an issue. She is researching a way the City can still provide this service for a fee and will present a proposal in the future.

Mayor Pro Tem Bass made a motion to approve the low bid of \$265,566.00 to K-DUG Corporation for Emergency Storm Drainage Improvements – Bay Street. This motion was seconded by Councilwoman Livingston and carried unanimously.

Councilwoman Hall made a motion to approve the first reading/adoption of an ordinance for Application for Rezoning filed by Lugo Properties, LLC, located at 757 Holmesville Ave., be rezoned from a Business (B-2) Zone to a Residential (RM-10) Zone in voting district 3. This motion was seconded by Councilwoman Livingston and carried unanimously.

City Manager Orvin announced that the Downtown Development Authority received a Rural Zone Designation for downtown revitalization.

Chief Taylor gave a presentation concerning the recent activity of the Baxley Police Department. He and the Department were thanked and commended on the progress and successful drug arrests.
