You must complete this addendum to preserve access to the New Mexico Motor Vehicles Division Vehicle Registration Suite (VRS), managed by New Mexico Interactive, LLC on behalf of the New Mexico Motor Vehicles Division. Read all the information carefully, complete and sign this form, and return it to the address noted above.

This online service allows licensed automobile dealers, license services, and other authorized retailers to generate and print temporary tags and access vehicle information through an existing Internet connection. Dealerships and Title Service Companies that do not have an Internet connection are required to call the VRS Call Center, provide transaction information, and receive temp tags via fax.
