Re: Casino closure

Premier Horgan, Minister Dix, Minister Kahlon, Dr. Henry, MLA. Sandhu

Casino employees live in our community. They coach sports, volunteer and care for their families. They are our neighbours, friends and loved ones. But since the beginning of the pandemic, they have not been able to work and that has put significant strain on finances and mental health.

Casinos also play a significant role in our community, not only as employers, but as a source of funds for local charities as well as municipal and provincial governments. In the case of the City of Vernon, \$2 million in casino revenue was anticipated in 2020 but, instead, there was a \$1.6 million shortfall. That's money not available for much-needed infrastructure upgrades and other projects.

We respectfully request that provincial authorities immediately work with the operators of casinos in B.C. to ensure measures are initiated that allow casinos to reopen while ensuring the health and safety of guests and staff.

It is interesting to note that B.C. is the only North American jurisdictions to not allow casinos to open and data indicates casinos have not been a source of community spread in other provinces.
