New Director Training Returns to the Leadership Seminar!

"Board Fundamentals for New Directors"
Sunday, May 21, 2023

Training new directors is essential for building a high-performing board. It's also key to keeping board members engaged and helping them understand their role. Developing training internally or bringing in a consultant can be costly and time-consuming, while relying on experienced directors to provide training isn't always practical. This course was developed with that in mind.

After taking this session, new directors will learn these key concepts:

- Understanding how credit unions differ from banks and why that matters

- Knowing the duties & responsibilities of an elected official of a financial cooperative
- Engaging in effective communication with other board members and staff
- Roles and relationship between the Board, the CEO and staff

This session is **ideal for first-term directors** and **associate directors who aspire to a board position**. Participants will get to ask questions they may have been afraid to ask in board meetings.

Membership Renewal Period Ends Soon

Be sure your credit union has renewed its annual membership in NACUC. Invoices were emailed to the billing contact at your credit union last month. If you have not renewed, please contact nacuc@nacuc.org to make sure your membership does not lapse.

- NACUC membership is group-based meaning your entire board enjoys the benefits of belonging, including discounts on event registrations fees
- If you're Board Chair, establish a legacy membership by inviting your Vice Chair (or next in line) to attend NACUC meetings

Members can now take advantage of an auto-renew option for annual dues payments. It's a convenient way to keep membership current by avoiding missed invoices and lapses in membership benefits.


