### **Eligibility**

All Nominees:

- Must be a full time resident of the Mountain Communities.
- Do not have to be members of the Lake Arrowhead Communities Chamber of Commerce or the business community.
- Every citizen in the Mountain Communities is eligible for this award with the exception of the officers and directors of the Lake Arrowhead Communities Chamber of Commerce and those receiving the award in the previous five years.

### **Criteria**

The Award Winner will be selected based on the responses to the following:

- Leadership and civic role in the Mountain Communities over several years.
- Key achievements demonstrating volunteerism and contributions to the Mountain Communities.
- Betterment of the community, their vision, and the execution of this vision that was vital for the betterment of the Mountain Communities.
