Economic Development Division:

- Support efforts to address the affordable workforce housing shortage through implementation of the City's "Housing Roadmap" and by actively participating on the Whitefish Community Housing Committee and work groups.
- Work with Housing Whitefish to create an employer-funded revenue stream to support the community's Workforce Housing efforts, and to promote employer-assisted housing programs.
- Encourage the Whitefish City Council to implement the Public Transit element of its new Transportation Plan and investigate the potential for expanding public transit options to reduce peak season traffic, ease downtown parking issues and connect local workers to their jobsites. Also explore need for better transit options between town, the airport and Glacier National Park.
- Support Glacier AERO and its efforts to attract more frequent and affordable air service to Glacier Park International Airport; specifically targeting winter (ski season) flights.
- Maintain focus on growing fall and spring shoulder season tourism.

Government Affairs Division:

- Monitor the activities of local government; advocate for programs, policies and decisions that have a positive impact on local businesses and the Whitefish economy.
- Encourage fiscal restraint and common sense in spending taxpayer dollars.
- Encourage business community representation on the appropriate City and County committees and task forces, including: the Whitefish Community Housing Committee, the Impact Fee Review and Growth Policy Update committees, and Planning Board.
- Participate in regional homeless/mental health discussions.
- Educate and inform Chamber members (and the public) about issues pending before state and local governments that could adversely impact their business and/or the region's economy.

Member Services Division:

- Host monthly Gone Fishin' networking events on the third Thursday of each month.
- Host monthly "Business Buzz" networking events on the first Thursday of each month.
- Host quarterly "Let's Be Bold" ladies symposium events in February, May, August, and November.
- Replace/upgrade www.WhitefishChamber.org
- Staff the city's official Visitor Center at least 40 hours/week, year-round.
- Encourage members to supply brochures and business cards for distribution at the Visitor Center, and by taking advantage of other member marketing opportunities.
- Maintain & update the Chamber website and Special Events/Community Calendars.
- Distribute Chamber Chat eNewsletter weekly.
- Publish the *Whitefish Community Guide* (community profile and visitor/relocation guide) annually.
- Review and enhance member benefits annually.
- Explore opportunities to ally with other local Chambers and business organizations; participate in multi-Chamber "Mega-Mixer" in May 2023.
