GREEN BUSINESS SANTA BARBARA COUNTY

The Green Business Program of Santa Barbara County (GBPSBC) continues a tradition begun in 1994 of recognizing businesses that take actions to protect, preserve, and improve the environment. The Central Coast's business community has recognized that environmental responsibility and green practices not only benefit our community but they can save businesses money.

The GBPSBC certifies businesses that go above and beyond complying with applicable regulations by implementing measures in such areas as solid waste reduction and recycling, environmentally preferable purchasing, energy and water conservation, and pollution prevention.



To become certified, a business must implement certain mandatory and a minimum number of voluntary measures in these areas. There is no cost to apply and free technical assistance is available, although a business will be responsible for costs associated with upgrades to its operations and facilities. Rebates are available to offset some of these costs.

Earning a certificate from the GBPSBC means you have made a commitment to your community and the future success of your business - so go above and beyond typical green measures and stand on the cutting edge of sustainable business practices.
