

## Alabama Accredited Chamber Executive Program (AACE)

## **Background**

The Chamber of Commerce Association of Alabama (Alabama Chambers) established the Alabama Accredited Chamber Executive (AACE) Program to recognize the professional competence of chamber of commerce executives in the State of Alabama. The AACE designation is based upon the experience, service to Alabama Chambers, training, continuing education and professional achievement of Alabama Chambers members. The AACE award is intended to strengthen the career development objectives of Alabama Chambers and provide personal recognition to chamber professionals in Alabama.

Selected recipients receive professional certification that can be included with the recipient's profile, biography and resume.

## AACE Designation Process

Any Alabama chamber professional with a <u>minimum of five years of experience as a Chief Paid Executive or</u> <u>Senior Staff Member</u> is eligible to apply for the designation. If you have already achieved the Certified Chamber Executive (CCE) designation, and you have met the minimum of five years of experience as a Chief Paid Executive or Senior Staff Member and have been employed by a Chamber in Alabama for a minimum of 24 months, you may apply and receive the AACE designation by paying the application fee.

The Program is a 3-part process:

- 1. <u>Application</u> applicant must complete the attached program application and supply supporting documentation for each question that applies. **Applications submitted without proper documentation will not be considered.**
- 2. <u>Essay</u> applicant must prepare a 250-word or more essay describing your views on your performance as a Chamber Executive or Senior Staff member.
- 3. <u>Recommendations</u> application must provide letters of recommendation from each of the following:
  - a. Current Chamber Board Chair
  - b. A Past Chamber Chair
  - c. Two Alabama Chamber Peers

The applicant must provide the information electronically – preferably via a Dropbox folder. The applicant must also pay a **<u>\$150.00 processing fee</u>** made payable to the Chamber of Commerce Association of Alabama which may be paid via check. The AACE committee may request additional information from the applicant to clarify specific criteria. Upon approval by the AACE committee, the applicant will be awarded the AACE designation at the upcoming Executive Leadership Conference. Once received, the AACE designation will remain with you and is not required to be renewed.

### **Deadline for Applications**

Applications & materials should be received by Friday, March 7, 2025.
