2022 AT A GLANCE

Advocacy

The Chamber advocates on behalf of members and local business issues by engagement with the top decision makers at each level of government. We participate in and host member and business stakeholder roundtables with industry leaders and elected officials. This provides direct policy or program input, information exchange, feedback and constructive dialogue by sharing of expertise and on the ground experiences.

BC & Canadian Chamber

We leverage our membership in the BC and Canadian Chamber networks, strategic industry and community partnerships to move the dial on effective solutions. Every year the Chamber is a leading voice at the BC and Canadian Chamber Annual AGM and Policy Conventions and involved with a calendar of outreach opportunities.

Shop Local Advocacy Campaign

Beginning in 2022 and into the Spring, the Chamber collaborated with the Abbotsford Downtown Business Association on an "Abby Loyal" and "Hey Neighbour" shop local promotional campaign. It featured a variety of our local businesses across the City on digital and print advertising, as well as an online contest. Funding was provided by the Federal government through the BC Chamber of Commerce and was an initiative to continue support during pandemic recovery.



Advocacy Issue Highlights

Advocacy is the heart of what our Chamber does to communicate to all levels of government and partners on business issues for our members. One key way we advocate is through our policy development process and stakeholder engagement. This involves Chamber leadership and collaboration to work on solutions for our local businesses and organizations. Our Government Affairs Committee identifies and analyzes concerns of the business community and recommends evidence-based policy positions to the Board of Directors for decision. We work to gain support of regional Chambers, the BC Chamber and the Canadian Chamber at annual policy conventions and at other opportunities throughout the year.

2022 advocacy highlights included the following policies and topics:

- Keep BC Growing through Responsible Resource Development
- Floods An Emerging Economic Threat Requiring Action
- Ensuring an Effective Affordable Childcare Model for BC
- Strategic Management of the Lower Fraser River in BC
- Presentation and input into the 2022 Federal and Provincial Electoral Boundaries Proposed Re-Distributions at Community Hearings and through written submissions.
- Presentation of the Chamber's Not-for-Profit and Agriculture Economic Impact Studies to the City's Business, Innovation and Public Affairs Committee.

Canada's Agricultural Hub: An Economic Impact Analysis of Agriculture in Abbotsford

In 2020, as a follow up to our highly successful 2008 Agriculture Study the Chamber, partnered with University of the Fraser Valley, City of Abbotsford, TD Bank and with support from the University of British Columbia to produce a new Agricultural Impact Study, "Canada's Agricultural Hub: An Economic Impact Analysis of Agriculture in Abbotsford (2022)." In May of 2022, the Chamber hosted a luncheon featuring BC Agriculture Minister, Lana Popham as the keynote and a panel discussion to launch the release of the report and share its findings to the community.

Since then, the Chamber has been actively pursuing a community outreach and engagement strategy through the Chamber's Agriculture Committee to disseminate the nationally significant findings of this leading work. Flood Disaster Relief Support



In 2022, the Abbotsford Chamber of Commerce continued to provide flood disaster relief support for the long term impacts that resulted from the catastrophic November 2021 floods. Along with its Abbotsford Disaster Relief Fund Coalition partners: the Abbotsford Community Foundation and University of the Fraser Valley, the Chamber continued to grant funds from the over \$4 million dollars raised and coordinated with local agencies doing ongoing work.

BC Economic Development Award 2022

In April 2022, the Abbotsford Chamber of Commerce was awarded a BC Economic Development Award for its part and granting stream to administer funding to local businesses and farmers that suffered from the floods. The Chamber and its Coalition partners who were critical to this achievement were recognized.



One Year After the Floods Event

In November 2022, the ADRF partners organized a Donor Appreciation event featuring heart felt stories from flood victims; not for profits, farmers and local businesses. The event was hosted at the University of the Fraser Valley.



Connecting through Meaningful Experiences & Benefit Programs

The Company of Young Professionals & **Entrepreneurs (CYPE) Program**

In 2019, the Abbotsford Chamber of Commerce initiated the development of a new program, the "Company of Young Professionals & Entrepreneurs" (CYPE) meant to provide leadership, connecting and growth opportunities for the next generation and those 40 years of age and under. Since then groundwork has been laid including in 2021, with the creation of CYPE's Strategic Plan 2021-2023 and established two annual events: the Annual Summer Social in partnership with the Fraser Valley Indo-Canadian Business Association and the Annual Christmas Mingler.

Most recently in 2022, the CYPE formed their Leadership Council and were part of informing the Chamber's new brand identity. The program has been growing and gaining traction in the community each year of its existence. Program sponsorship from RBC and the Abbotsford Tech District has supported this growth.






Cost Saving Opportunities...
