

### **INTRODUCTION OF BILL 10 AND UNION CERTIFICATION**



#### May 19, 2022

**Abbotsford, B.C.** - Business associations and leaders across the province have been advocating against the provincial government's introduction of legislation that removes the secret ballot from voting on joining a union. In a letter this month to the Premier of BC, 23 organizations and their collective membership wrote to express dismay with the changes the government has proposed to the certification provisions of the Labour Relations Code ("the Code").

The letter includes warnings that these changes will have economic repercussions across the province as businesses work to recover from the impacts of COVID-19. They will also needlessly destabilize the labour relations balance in British Columbia. Furthermore, concern was expressed that there has been no consultation and that the action of the government calls into question its commitment to open and transparent consultation. Bill 10 legislation goes against the majority recommendation of the 2018 Section 3 Labour Relations Code Panel Review Report, chaired by Michael Fleming.

The letter also states that, "the secret ballot is a fundamental component of our democratic system and a standard that should apply in workplaces just as it does in other facets of public life. Workers in British Columbia have a right to join a union and our organizations believe in and respect the collective bargaining process. Workers also have the right to make this decision in a manner that is free from influence. The secret ballot is essential to protecting that right. Our view, expressed to your government in the past, is that the province, employers, organized labour and workers, do not benefit from see-saw labour regimes as governments inevitably shift over time. British Columbia needs labour stability as we turn our attention to recovery from the pandemic."

"The Labour Relations Code and the Charter of Rights uphold the right for workers to choose union representation...Fundamentally, Bill 10 weakens the democratic rights of workers and undercuts fairness, clarity and certainty for workers and employers alike. At a time when the government is seeking to create a more inclusive economy, implementing changes as proposed in Bill 10 will foster divisiveness within the workplace at a time when we all need to be focusing on recovery and growing our economy for the benefit of all British Columbians. We call on the government to withdraw Bill 10 and to undertake proper consultations with stakeholders."

A joint industry statement was made as well last month in April, by the BC Chamber of Commerce, BC Business Council, Canadian Federation of Independent Business, Greater Vancouver Board of Trade and Surrey Board of Trade:

The following associations are surprised by the introduction of amendments to Bill 10 by the BC government, which proposes substantive change to the Labour Relations Code without any meaningful consultation with employers, and at a time when many businesses are still reeling from the pandemic.

The right to choose union representation is guaranteed through legislation. The method of how workers choose to decide who should represent them is critical. Fundamentally, Bill 10 significantly weakens the democratic right for workers to exercise choice through a secret ballot. These changes also follow significant changes to the Labour Relations Code in 2019.

We are disappointed that the Minister did not fulfill his 2022 mandate letter responsibility to "create new consultative mechanisms to engage employer and worker representatives in consideration of any changes proposed to workplace legislation to ensure the widest possible support."

We call on the government to pause the legislative process and engage in a fulsome and proper consultation with employers.
