Abbotsford Chamber Continues to Push for Federal CEBA Loan Extension

The Premiers of every province and territory launched the CEBA loan program, with eligible across Canada have agreed that the repayment deadline for CEBA (Canadian Emergency Business Account) loans for struggling businesses needs to be extended by the federal government. The Abbotsford Chamber of Commerce applauds BC Premier David Eby for joining the fight for an extension by signing a joint letter to the Prime Minister, following concerted advocacy efforts by Chambers of Commerce.

The recent announcement by the federal government of a minor extension of the CEBA loan program does not go far enough and will do little to ease business owners' worry about the looming repayment deadline and losing thousands in debt forgiveness.

What small businesses really need is a 2-year extension to the CEBA (Canadian Emergency Benefit Account).

Unfortunately for most businesses, the CEBA loan extension is, in practise, only an 18-day extension than the original deadline, moving the goalpost to January 18, 2024. And for those businesses that can secure refinancing, it only extends it until March 28, 2024.

"For months, the Abbotsford Chamber has been tirelessly advocating for a two-year extension on the repayment of these loans. It's encouraging that Premiers from across Canada have chosen to speak as a united front to protect the businesses that are most in need of support," said Chamber CEO Alex Mitchell. "Business owners are still in recovery, particularly as they face some significant economic headwinds in a high-cost operating environment. What we need most right now is stability for small business."

In response to the COVID-19 pandemic's effect on the economy in 2020, the Government of Canada

businesses receiving up to a \$60,000 interest-free loan. Prior to the new announcement, the deadline to repay the loan was on or before December 31, 2023, for eligible CEBA borrowers in good standing, resulting in loan forgiveness of up to 33 percent (up to \$20,000).

Businesses that do not repay the loan in full by the new deadlines will lose the forgivable portion of up to \$20,000, and the loan will convert to a new low-interest loan. This announcement did extend the repayment of these new loans by an additional year to December 31, 2026.

The Chamber will continue to monitor the implementation of this announcement and to continue pushing for a meaningful loan extension. Economic recovery in Canada is still underway, affected by key challenges from the lasting impacts of the pandemic, labour shortages, disruption to supply chains, and rising inflation and interest rates and businesses continue to face outsized challenges that make it increasingly challenging to operate.
